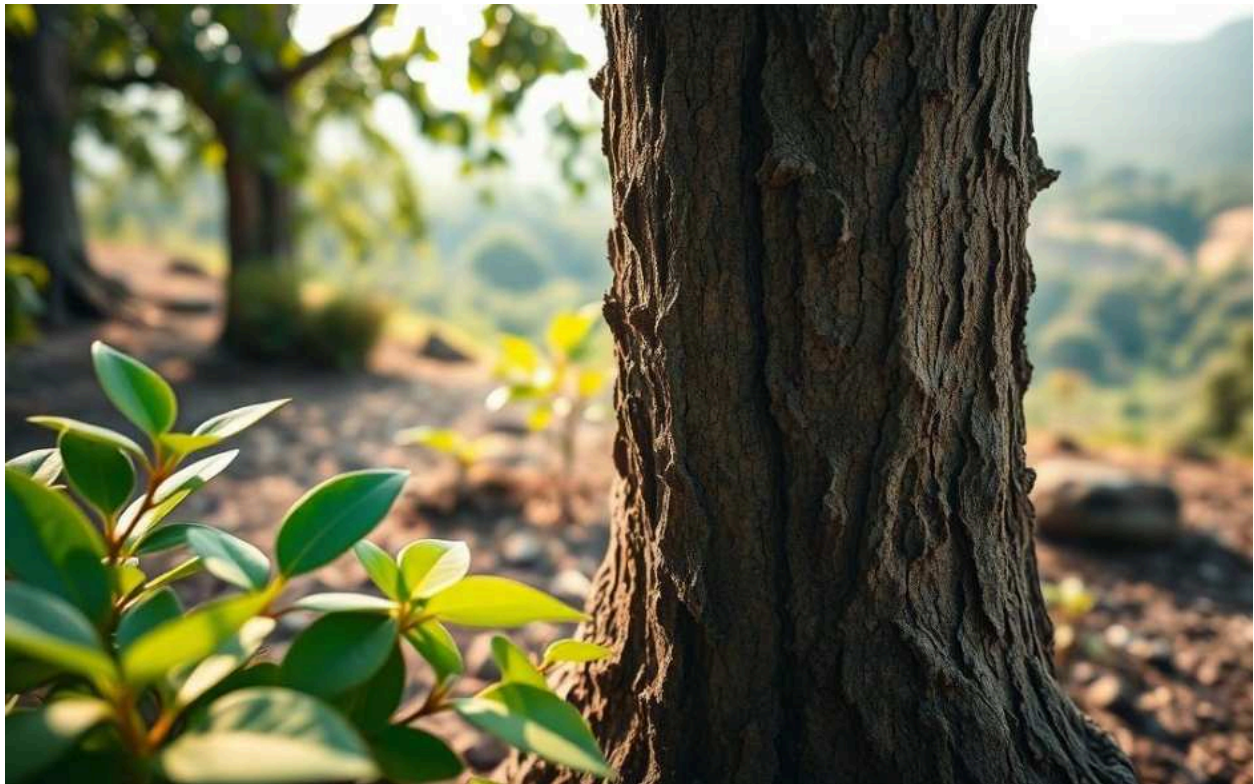

Log your urinary frequency, nighttime trips, and pelvic muscle tone. Note any energy or skin changes. Expect improvements in 60–90 days.
