2025 Letter from the CEO and Board Chair

Your inspiring kindness surrounded 18,798 pediatric patient families with love and practical support from Ronald McDonald House Mountain West last year. Thank you! This represents record mission impact for 50,542 individuals.

Please enjoy our Annual Report, which summarizes our mission impact, celebrates our generous volunteers and donors, and honors the pediatric patient families who inspire us. Each gift of time, talent, and treasure—large and small—helped provide direct and practical support and care for pediatric patient families.

The numbers tell an incredible story of growth and service: Our Ronald McDonald House hosted 3,004 families with an average length of stay of 20 nights, while our hospital-based programs served 15,794 families. We offered 31,226 nights of free lodging, transportation to and from hospitals, compassionate family-centered care and joyful distractions. Volunteers lovingly shared over 55,606 hours of service valued at more than \$2M—a 50% increase from the prior year. Together we provided 94,780 free meals at our Ronald McDonald House and hospital-based Ronald McDonald House Family Room® programs.

We also expanded our Family Support Services team to offer more skilled mental health and grief support while connecting families with critical resources as they are experiencing a health crisis with their child. We saw unprecedented occupancy and hospital referrals for families with seriously ill or injured children, providing care bags to families we were unable to serve on nights when rooms were full. And in September, we were honored to launch an innovative Ronald McDonald House Family Room program within the newly constructed Intermountain Primary Children's Hospital Behavioral Health Center in Taylorsville, Utah.

We are deeply grateful to the donors who fuel our mission, our remarkable staff who bring our mission to life, our volunteer Board of Directors for their exceptional stewardship, and our local McDonald's owner-operators and their customers for providing record support through the "Round Up" and "Fries for Families" programs!

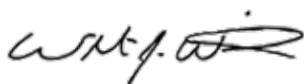
Most of all, we honor the children and families who face unimaginable challenges with inspiring courage and love.

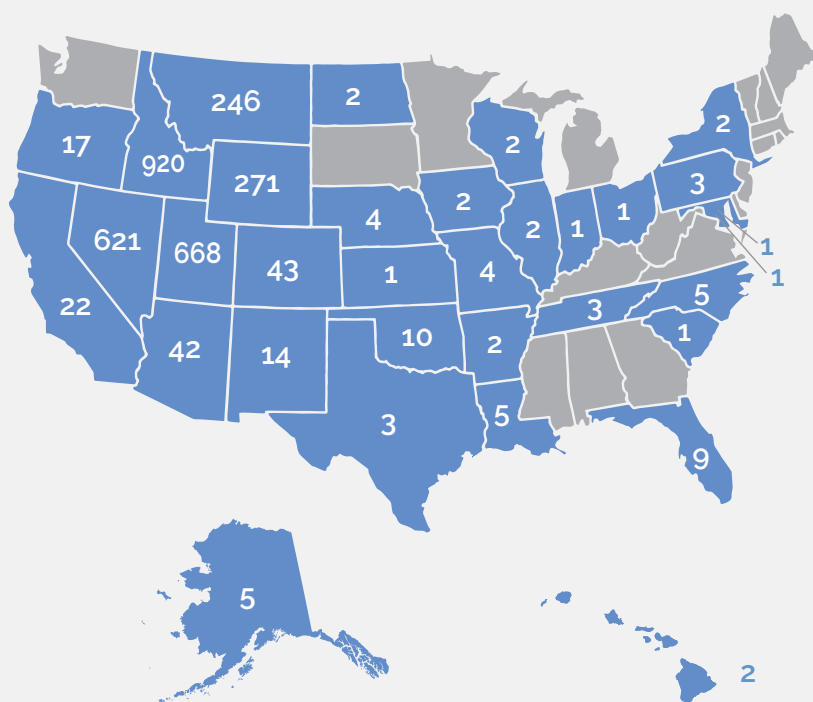

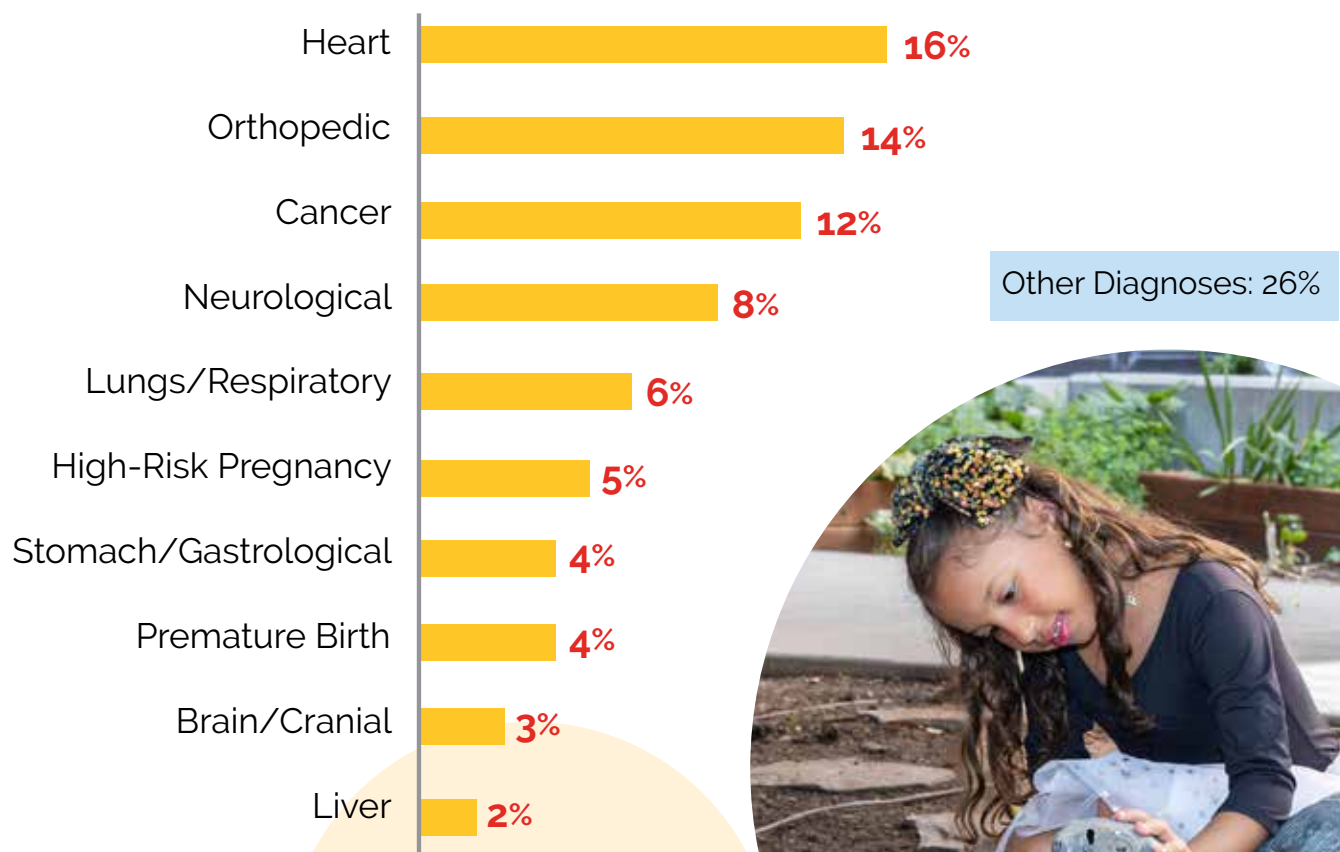

We were thrilled to open a brand new Ronald McDonald House Family Room in 2025. It is located at Intermountain Primary Children's Hospital Behavioral Health Center in Taylorsville. This pioneering space is one of the only Family Rooms in the world located within a treatment center focused on behavioral health. This beautiful new space features two overnight guest rooms, a kitchenette with snacks and drinks, quiet spaces, a laundry facility, showers and restrooms, Wi-Fi access, and more!

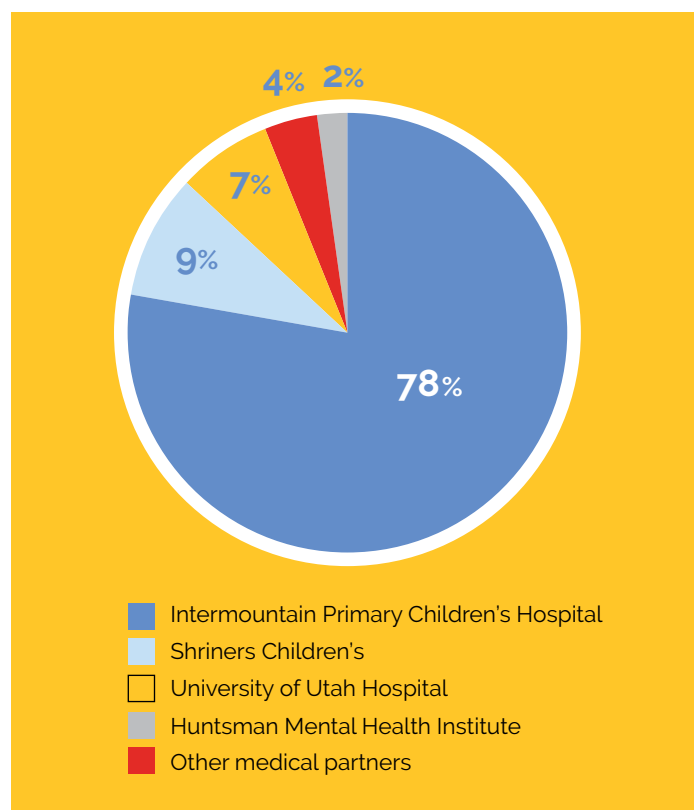


Enhancing Collaboration

We surround families with more than walls and a roof. It takes a whole community to provide the best family-centered care. From the hospitals that refer families to the House, to local organizations that provide meals, groceries, and once-in-a-lifetime experiences, collaboration helps us extend care beyond lodging. These partnerships make it possible for families to focus on what matters most: being there for their child.

Hospital Partnerships

Our hospital partners are the House's "front door." In 2025, referrals came from across the region's pediatric care network:



Hospitality Partners

When families face long hospital stays or life-changing diagnoses, moments of joy matter. Community partners helped create meaningful experiences this year—from once-in-a-lifetime outings to milestone celebrations.

Hogle Zoo provided a behind-the-scenes animal encounter, allowing a young patient and family to feed meerkats and warthogs. Gourmandise provided beautifully prepared dishes for family celebrations. The Melting Pot created a memorable anniversary dinner



for a family staying at the House. Local creatives—including videographers, photographers, officiants, and bakers—donated their talents to make a family wedding possible during a medically complex pregnancy.

Generous partners like these remind families that even during difficult seasons, there is still space for celebration, connection, and joy.

Food Partnerships

A strong network of food partners helps ensure families always have access to meals, groceries, and essential supplies while caring for their hospitalized child.

The Church of Jesus Christ of Latter-day Saints Bishops' Storehouse annually contributes \$100k for food commodities.

Fed Up Kitchen helpfully donates delicious meals each week.

Innovative Deliveries + Local Good coordinated weekly pickups from food donors and deliveries to the House and Family Rooms—completing nearly 100 routes and assisting with large holiday donation transport.

Utah Food Bank expanded support in 2025 by increasing warehouse pickups from two to three each month, boosting our food resources by 50%.

SWIRE Coca-Cola helped launch our Meal Kit Program, providing over 11,000 meals in 2025 and expanding to three meals per month in 2026.

Tabitha's Way provided regular grocery donations to the Lehi Family Room, contributing an estimated \$9,600 in food.

American Fork Walmart donated more than \$7,000 in groceries and supplies to support weekly needs at Lehi's Family Room.

Chick-fil-A, Costa Vida, Crust Club, and Kneaders provided discounted catering so volunteers could easily provide meals through our Together at the Table program.

Little Caesars, our "on-call" partner for last-minute needs stepped in seven times in 2025 to feed 210+ people when meal groups had to cancel.

Better Days Co. donated \$164,000 worth of powdered drink mixes, helping keep families stocked with beverages throughout the year.

THE HONORARY GRANDPARENTS FUND: *Creating memorable moments for families with children who have a life-limiting or life-altering diagnosis.*



We love creating moments of joy for families as they face some of life's most difficult chapters. These experiences create lasting memories beyond hospital walls. Our donors made experiences like these possible in 2025:

After months of recovery following a heart transplant, Dean Godecke was finally strong enough to venture out.

Because he loves animals—and had never been to a zoo—partners at Hogle Zoo arranged a behind-the-scenes experience where Dean got to feed meerkats and warthogs alongside his family.

For the Bernal family, the fund helped make a deeply personal milestone possible. While staying at the House during a high-risk pregnancy, Diana shared that she hoped to marry Enrique before their son Mateo was born. With only days to spare, staff and community partners came together to host a joyful wedding at the House.

The fund also helped families celebrate meaningful moments, like a special dinner out for Mark and Eva Valencia while their premature daughter Mary grew stronger in the hospital.

Established by Bert and Lynn Zimmerli in honor of Bert's father, the Honorary Grandparents Fund continues to create opportunities for families to pause, celebrate, and make lasting memories together—even in the midst of uncertainty.

Family Support Services Program

Maria Gamvroulas and Kyle Henderson provide family-centered crisis intervention and mental health support for pediatric patient families, offering collaborative case management and referrals to essential community resources. In 2025, their collaborations with hospital partners nearly doubled, supporting more families with complex diagnoses, who travel further distances, and stay for longer lengths of time on average.

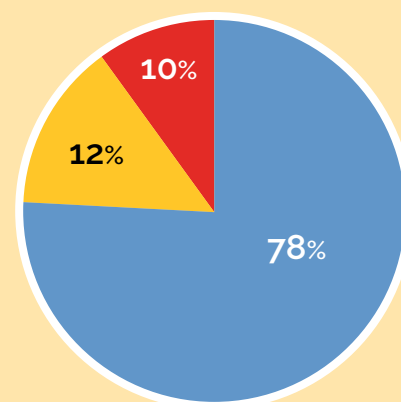
