## LETTER FROM LEADERSHIP

Dear Friends and Supporters,

We are making a difference together! The Sarita and Claire Wright Lucas Foundation's (SCWLF) last five years were full of accomplishments and opportunities for learning and reflection. While each year has posed its challenges, making it through year five amidst a global pandemic shows that SCWLF has built a sustainable platform, improved the lives of our scholarship recipients, and ultimately continues the legacies of Sarita and Claire Wright Lucas.

Our list of supporters has grown. We have raised awareness of the need for more diversity and inclusion among prosecutors in all jurisdictions. Yet, there is so much more work to be done.

The fact remains that in the criminal justice system, Black women comprise only 1% of prosecutors NATIONWIDE.

Prosecutors possess formidable power to carry out justice. They decide whom to prosecute, what to charge, whether to recommend freedom or incarceration before trial, whether to bargain for a plea and its conditions, and whether to dismiss a case altogether. They hold this authority throughout the life of a criminal case, giving them extraordinary power from arrest through trial, conviction, and sentencing, as well as during appeals.

SCWLF is committed to RAISING awareness of the role of the prosecutor and promoting an understanding of why varied life experiences and perspectives of Black women must be of high value in prosecutorial offices. We encourage and support outstanding young Black women as they take on prosecutors' visible and essential role. In this way, we are working to ensure a fair and equitable justice system.

A recent Sarita & Claire Wright Lucas fellowship awardee said it best.

## ABOUT THE SARITA AND CLAIRE WRIGHT LUCAS FOUNDATION

Black women prosecutors are trailblazers. They are out-of-box thinkers, leaders, and change-makers. And yet, only 1% of prosecutors nationwide are Black women. For women of color, the prosecutor's career comes with heavy baggage, from inadequate financial compensation to student loan debt to bar exam prep and fees.



### **Enter the Sarita & Claire Wright Lucas Foundation:**

Inspired by the life of her late daughter Sarita Wright Lucas and unborn granddaughter Claire, Wanda Geer created the Sarita & Claire Wright Lucas Foundation in their honor. By witnessing Sarita follow her dreams in the prosecution office, Wanda had a unique insight into the trials and tribulations that women of color face in the field. She found inspiration in Sarita's dedication to helping those who need it most, her willingness to make sacrifices, and outright tenacity in a profession largely untouched by women of color. Wanda created the Sarita and Claire Wright Lucas Foundation to support women of color like Sarita as they break into an impactful career field.



# *We Fulfill Our Mission With These Initiatives*

## **The Scholarship**

The journey to the prosecution office is long, tiring, and often financially heavy. Since 2015, the Sarita & Claire Wright Lucas Foundation has aimed to ease this financial burden.

Law school debt is irrefutable. What's not so well known is the need for additional funds to prepare for the Bar exam. In addition to the cost of a prep course – at about \$5,000 – many recent graduates must take out personal loans to cover living expenses as they take on the full-time, unpaid work of preparing for the exam.

Unlike many law graduates who head to the private sector, those who choose to work for public agencies are on their own to financially prepare for the Bar exam. Those initial upfront costs are steep enough to steer women of color away from

careers in the public sector, and in turn, the prosecutor's office. SCWLF combats this.

SCWLF proudly offers scholarships to Black women law students dedicated to becoming prosecutors and preparing to take the bar exam. The \$10,000 scholarship consists of two awards. The first \$5,000 covers prep course fees for the bar exam, bar application, and living expenses. This award helps ensure that awardees have the necessary time to study and not worry about their financial income.

The second \$5,000 of the scholarship is the employment incentive. The SCWLF aims to support and encourage Black women to become prosecutors. One year after an awardee obtains employment at a prosecutor's office, they can receive the remainder of their scholarship.

On June 1, 2021, the Sarita and Claire Wright Lucas Foundation launched the Sarita and Claire Wright Lucas Foundation Network: The Journey to Becoming a Prosecutor (and beyond). With its home in a Facebook group, this moderated page now serves as a community not only for our new scholarship awardees studying for the bar and our fellows but our former awardees who have already begun their careers in the prosecutor's office. Additionally, we plan to include current Black female prosecutors outside of the foundation and thought-leaders in the justice system. The network is just one aspect of our support system for our awardees.

Graduating mid-pandemic, Amber's journey to the prosecution office was unique. Initially committing to JAG, Amber credits her pivot, to The Office of the State's Attorney for Harford County, Maryland, to the network she gained from the Sarita & Claire Wright Lucas Foundation.



### Abolore Oshodi

As the first Sarita & Claire Wright Lucas Scholarship awardee, Abolore's scholarship outcome is close to the foundation's heart. A Howard Law School graduate, Abolore quickly found her way to the prosecution office. Since 2016 she has been an essential asset to the Delaware Department of Justice. Additionally, she has kept the foundation a priority to her service. From contributing to the foundation Facebook network to regular participation as a foundation ambassador at foundation events, Abolore advocates why Black women prosecutors matter.

## THE FELLOWSHIP

In the summer of 2021, the Sarita and Claire Wright Lucas Foundation launched **The Sarita & Claire Wright Lucas Foundation Fellowship**. The SCWLF Summer Fellowship Program aims to provide Black female law students with a paid summer internship opportunity in the Massachusetts Suffolk and Middlesex District Attorney's offices.

Fellows attend professional development programming created by the District Attorney's offices, work in the courts alongside prosecutors gaining real trial experience and receive mentorship throughout their experience. Each Fellow receives a \$7,000 stipend for the 10-week summer program.

An active member of her community, Justine is currently the Secretary of the Suffolk University Black Law Student Association and a member of the Women of Color Law Student Association. ## **2020 Financial Report**

Like many young non-profit foundations, the Sarita and Claire Wright Lucas Foundation has faced challenges to its growth. At the beginning of 2020 the nation and the world dealt with tremendous challenges. We were unsure if we would be able to support the scholarship awardees in 2020. Despite the uncertainty the pandemic presented, because of support from our friends and donors, we provided two scholarships (\$10,00 each) totaling \$20,000 in money awarded.

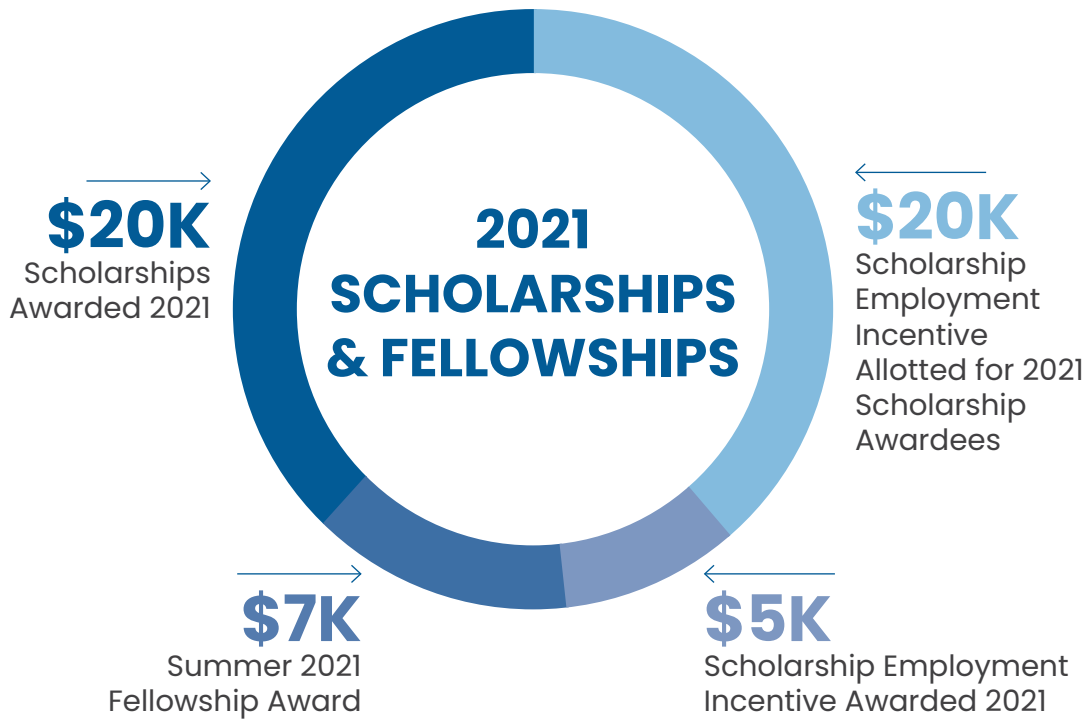

**Bethany N. Serota, Esq.** is the Deputy Director of Programs and Operations for the Mayor's Office of Workforce Development for the City of Boston. Mayor Walsh charged Bethany with creating Project Opportunity, a program designed to support second chance residents impacted by their criminal record. In partnership with the Mayor's Office of Public Safety and the Lawyers Clearinghouse, Project Opportunity offers free CORI sealing and expungement clinics, convenes panels on CORI challenges and solutions, and trains front line workers who support justice-involved individuals. Prior to this role, Bethany served as the Deputy Director for the Mayor's Office of Fair Housing and Equity for the City of Boston where she oversaw investigations of allegations of housing discrimination, increased equitable access to affordable housing, and enforced the Fair Housing Act.

Bethany is a 2020 Fellow graduate of The Partnership, Inc. Bethany co-founded and co-directed G.I.R.L.S. R.U.L.E., an empowerment program for teenage girls in Roxbury. She is also a member of the Citizen's Housing and Planning Association, the Massachusetts Academy of Trial Attorneys, and the Nine Streets Neighborhood Association in Roxbury.



Recently hired as Prosecutor in the California Alameda County District Attorney's Office, **Marisa Tagliareni** served as an Assistant District Attorney for the Middlesex District Attorney's Office in Woburn, Massachusetts for 15 years. Marisa joined the Sarita and Claire Wright Lucas Foundation's Boston Steering committee in 2017, she is an active fundraiser for the Massachusetts Chapter of ALS, and has served as a volunteer mentor for the Big Sister Association of Greater Boston.

Marisa received her B.S. from Georgetown University and J.D. from Suffolk University Law School.

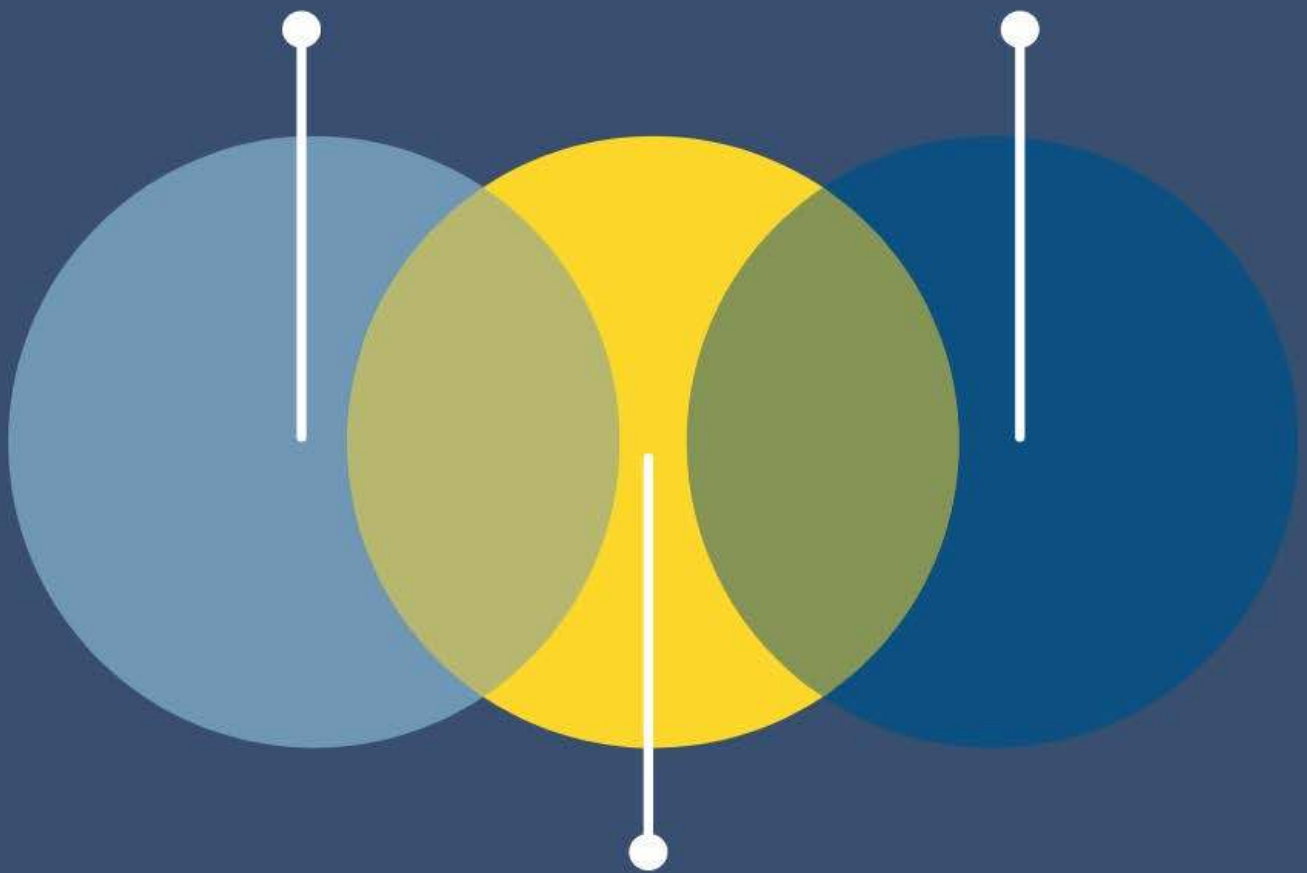
