DID YOU KNOW?

Recent federal legislation includes several provisions to help individuals & businesses who give to charities. Please consult your financial advisor or accountant for more information on how this applies to you.

- ✓ Individuals (including married individuals filing separate returns) can claim a deduction up to \$300 for cash contributions made to Rend Lake College Foundation, or qualifying charity during 2021.
- ✓ The deduction is increased to \$600 for married individuals filing a joint return.
- Individuals who itemize can apply an increased limit, up to 100% of their AGI (adjusted gross income), for qualified contributions made during 2021.
- ✓ Individuals age 70.5 and older can make qualified charitable distributions (QCDs) from their IRAs during 2021.

CREATING A LEGACY

HONORING AJ WELLEN'S SELFLESSNESS

AJ Wellen lived for the service of others. One of the last things he ever did on February 8, 2019, was to help his friends at Ron's Liquor Hut in Piopolis pump out water that had flooded the business after a heavy rainfall. Sadly, AJ died unexpectedly of a heart attack later that same day.

Now those same people AJ helped have made it possible for his legacy to continue helping others. "AJ never had a bad word to say about anyone," Lynn Bouseman, co-owner of the Liquor Hut said. "He was a really, really, really good friend to many people. With his sudden death, we wanted to do something to help. We really wanted to give back in his name."

Because of AJ's selflessness, Bouseman and other friends decided to raise money to award a scholarship in AJ's memory. Their fundraising efforts were so successful that the group was able to establish an endowed scholarship through the RLC Foundation.

The AJ Wellen Memorial Scholarship is now a perpetual scholarship that honors a life well lived t hrough service to others and generosity. The scholarship award criteria is a full-time RLC

student from Hamilton County who is enrolled in a vocational program (Ag Mechanics, Welding, Machining, Industrial Electronic & Maintenance, or Diesel Technology).

"It's so fitting that he was there with this amazing group of people who would then continue this legacy for him," AJ's wife, Natalie Wellen, said. "I just think it's an amazing opportunity for his legacy to live on. It lives on through his children, grandchildren, and everyone who loved him. But this is an additional way to honor him."

AJ Wellen graduated from Rend Lake College in 1986. Always a farmer at heart, he took night classes so he could work at Continental Tire. Natalie Wellen said he chose the off-schedule course load so he could provide for his family.

Those closest to AJ remember him as someone who would always be willing to help out anyone in need.

"They remember how funny he was," Natalie Wellen said. "He had the most amazing sense of humor and was just a sweetheart. He was always willing to help everybody and I think that's one of the great things about having the scholarship like this is in his name, he gets to continue helping people."

Ron's Liquor Hut hosts an annual AJ Memorial Fish Fry in late spring after farming season has ended. The event includes a silent auction, T-shirt and koozie sales, and a day of live entertainment.

"We have a close-knit community of friends and acquaintances who want to help out," Bouseman said. "People are very generous when it comes to the silent auction."

The group has also set aside funds to help purchase FFA coats for Hamilton County High School students who would not be able to buy their own.

"Giving back is probably the best thing you can do when you've lost someone who is so near and dear," Bouseman said. "Take that energy and help make the world a better place."

"It's just so cool that they thought through how to really get to what the heart of who AJ was and what he cared about. I want to

thank everyone for giving," Natalie Wellen said, "and let everyone know that there was an amazing person who started it all."■

SHINING BRIGHT FOR FUTURE GENERATIONS

On September 17th, Rend Lake College held a ribbon-cutting ceremony for the recently renovated Mary and George Slankard Learning Resource Center on the main campus. The building was renamed by the RLC Board of Trustees in April to celebrate and honor the late George and Mary Slankard of Sesser, who were longtime supporters of education and devoted significant financial and moral support for the mission of Rend Lake College.

It was the Slankards who gave the lead gift to the RLC Foundation's HUB Learning Resource Center fundraising campaign in 2019 to expand and renovate the college's Learning Resource Center. The Slankards also made provisions in their estate to leave a substantial planned gift to the RLC Foundation to create scholarships for students.

The Slankards' connection to RLC goes back over two decades ago when George Sankard was first elected to the RLC Foundation Board of Directors in 1997. He was named an Emeritus member in June 2017 and is one of only five members to receive this prestigious status.

George Slankard was a 1943 graduate of Goode-Barren Township High School. After he graduated from the University of Illinois and Southern Illinois University, he would follow in his father's footsteps in publishing by running the C&H Publishing Co. and Slankard Publishing. Those publications included The Sesser Review newspaper (1941-1960), Cars & Parts, The Lunker Hole, Outdoor Illinois, Whistle, American Cooner, and Hunter's Horn.

Mary Slankard taught English at Sesser-Valier High School, and she was often revered as one of the best teachers many students had ever had. She also inspired many of her former students to pursue teaching as a career because of the influence she had in their lives.

The Slankards met while they were both educators at Sesser-Valier and became pillars of the community. They were married for nearly seventy years before George passed in March 2020 at 95 years old and Mary Slankard, age 91, passed away nine months later in December.

"There's no doubt how passionate the Slankards were about the importance of education. They dedicated their entire lives to learning – whether it was work-related or interest-related, George and Mary were always reading and learning," said Kay Zibby-Damron, RLC Foundation CEO. "They often talked about their concern for the future of our region and wanted to ensure there were educational opportunities for area students."

Longtime family friend and RLC Board of Trustee member Randall Crocker said he believed the Slankards exemplified the famous quote from Gandhi that stated, "Live as if you were to die tomorrow. Learn as if you were to live forever." Everything they believed in, he said, was in the pursuit of making things better for those around them.

"I often thought that George's contribution [to the Learning Resource Center] was because he knew his life was coming to an end," Crocker said. "[The Slankards] saw a way to contribute to something that will allow them to live forever."

George and Mary Slankard were incredibly kind and generous friends. Their legacy will remain strong at RLC and in the southern Illinois region for generations to come. ■

Since 2017, Mr. A's generous contributions have helped more than 350 students with scholarships, initially set up for Benton High School graduates, and now expands to RLC students from Franklin County.

"Mr. A is simply amazing. He is always looking for ways in which he can help because he has never forgotten how he was helped along his educational journey. Mr. A's impact on his corner of the world is so significant and has been such a blessing to RLC and our students." said Kay Zibby-Damron, CEO of the RLC Foundation.

RLC President Terry Wilkerson said it is hard to put in wordsthe difference Mr. A's contributions have made in the lives of hundreds of RLC students.

"Mr. A personifies paying it forward,"
Wilkerson said. "He has given his life and his
investments. He didn't spend it on himself. He
spends it on the kids and the future. You want to
see it in action and see it in person? You can actually
see it in him. It's hard to put into words what he is
doing for our students and what he's doing for this
college."

"I really appreciate everything that he has done for the community," Gulley said. "Education is really important to my family and for me as a second-generation college student. People like Mr. A help me to be able to go to school and pursue my passion."

"It makes you feel like you have got people rooting you on, someone to support you and someone who wants you to finish school and get your degree," said Reed Raubach, a sophomore from Thompsonville studying IT security.

Alexander said he is glad he is in a position to help so many people. Recently, Mr. A made a large contribution to his existing endowment to ensure the young students at Benton Elementary School will have scholarships when they come to RLC. "This is just another example of how Mr. A's generosity will impact future generations," said Zibby-Damron.

"You're making a positive difference in someone's life," Alexander said. "It's a good feeling."

A STUDENT'S JOURNEY

Winter Pittman has big aspirations. She intends to have a career not "just a job" as an elementary special education teacher. The RLC sophomore from Mount Vernon desires to become the kind of teacher she knows is needed in the world - one who is caring, patient, and willing to be an advocate for students.

"All I have ever wanted is to be a teacher," Winter said.

Winter's desire to help students in the classroom is just an example of her determination to overcome challenges and her nature to help others.

Winter knows all too well about challenges. At the tender age of 9, Winter lost her mother in a tragic accident. She and her younger brother, Joseph, who is disabled and requires full-time care, went to live with their grandparents.

THE BOND OF A SISTER & BROTHER

The bond between Winter and Joseph is tight, and Winter intends to be Joseph's caretaker into adulthood. "It has always been [Joseph and me]," she said. "I have only gone without seeing him for three weeks his entire life. I don't think I could be without him. He is the reason why I want to go into special education."

Winter is also determined to be the first person in her family to earn a college degree. Knowing her grandparents might not be able to pay for college, she applied for scholarships through the RLC Foundation to get additional help with her tuition and books.

Winter appreciates being given a chance to pursue higher education. "Having a scholarship [last year and this year] has been the best thing," said Winter. "It's a weight off my shoulders. Even though I work, it's not enough to pay for college."

Winter's story and her motivation for success is merely one example of the challenges many RLC students face while trying to create a better life for themselves. "Being able to help students on their journey is a priority for the RLC Foundation," said Kay Zibby-Damron, RLC Foundation CEO. "Without the generous donor support for our scholarship program from alumni, friends, and community businesses, we simply wouldn't be able to provide as many opportunities for deserving and hard-working students, like Winter."
