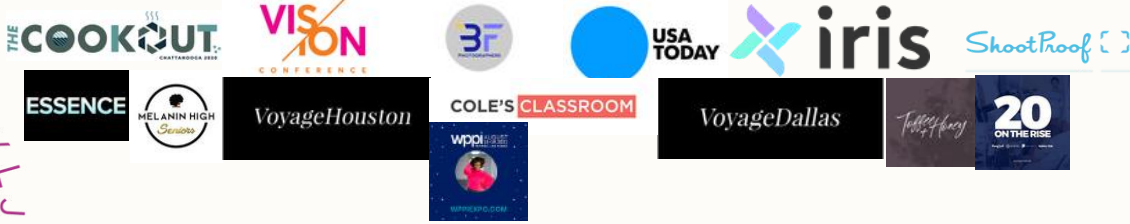

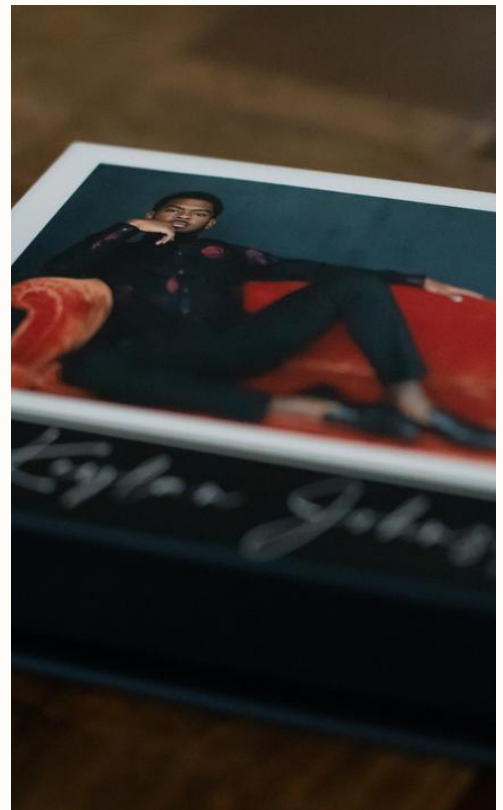

# Studio Policies

The following policies have been established to allow us to operate in a consistent and efficient manner. Your familiarity with these policies is important and will help insure a very memorable experience

**RSVP/ Travel Fees and Sessions** A non-refundable 40% retainer due the day of booking to reserve your date and time. No travel fee is required for miles up to 20 from 06110. Miles over 21 result in the regular government rate. Select weekday morning and afternoon sessions are available. Extra time is only available for purchase, to use after the last client of the day.

**Payment Reservation** is due upfront. Balance is due 3 days before session day. We accept payments from debit or credit cards, minus American Express + PayPal. Cash for print/product balance is acceptable.

**Cancellation/ Rescheduling** We require 3 business days notice in the event that you need to cancel or reschedule your session. If the photographer has to cancel for reasons out of her control, your session is fully refunded. If the client cancels, the retainer is kept by the photographer and the balance is refunded.

**Stealing / Cropping Images/ Copyright Infringement** Do not edit (add filters), crop, or alter images in any way. Please upload a full image from your computer. Cropping the photo destroys the image. Lastly, it's illegal to steal from the gallery AND to crop out the watermark. You will be invoiced \$100 per photo stolen from the gallery and possibly fined \$2,500 - \$42K. Be cool. Don't crop photos or steal from the gallery. It's disrespectful and dishonest to the photographer.

**Online gallery viewing from your session** Due to COVID-19, all gallery viewing will take place on ZOOM with your photographer. While the personal review process is the favored method of seeing your gallery, we want to remain safe. Once you sign the Copyright Infringement contract, your gallery will remain visible for 14 days (from session date) with a unique password for entry. You may reinstate your gallery for \$125 if you need more time to order. At the end of the 14 days, proofs are automatically removed from our website.

**Image File Archives** Image files are kept on our systems for 90 days to allow ample time to make your selections and complete your purchases. It's not guaranteed after the 90 period. Please plan on making all of your selections at your review session.

**Family Time for The Business** are Tuesdays, Thursdays and all major Holidays. We will get back to you the next business day.

**Receiving your final portraits** You order prints directly from your gallery. Announcements, Wall Art + Books are ordered through photographer. Prints + products are shipped to your home from photographer. Please allow up to 8 business days to receive prints + 4 weeks from the date to receive the photo books by mail.
